

# The New Workplace -As Seen Through The Eyes Of A Tradesman.

## Introduction:

This article is about something we might call **"The New Workplace"**. For the last fifteen years or so most people through out the Western World, who are in or associated with the workforce, would be more than aware of the profound changes in laws, procedures, responsibilities, liabilities etc. that have been introduced into the workplace. It should be noted that it is more than just coincidence that all western nations have adopted essentially the same package. It is either a most remarkable coincidence or it would be obvious that it has been arranged according to a **PLAN** - a plan which amounts to a conspiracy because there clearly is an enormous number of people and organisations involved and it is illegal Not illegal as against the laws of the land being passed but illegal in the sense that they are against

the natural law as upheld by the Holy Bible and will be clearly shown to be against the interests of Companies, Management and Employees. It will be the contention in this article that **"THE NEW WORKPLACE"**, hereafter called the **TNW**, is NOT just a coincidence or a mixture of good sounding ideas that

- **Psychological Research** organisations etc. have postulated and have drawn together and evolved over a period of time into an emerging monster we might call the **TNW**. The average person might think this sounds far fetched but the truth of the matter can only be understood in the light of a vast amount of changes taking place in the world which are rarely reported or would be considered of such little significance that they aren't worth being mentioned. As the old saying goes -

**"The devil is in the detail".**

This subject is deserving of a treatise that could contain volumes, but this author is NOT the one to do it!

As is often the case, a simple analogy can help greatly to see a very difficult subject in a simple light. The best analogy to describe the TNW is that of a jig-saw puzzle. A jig-saw puzzle has many pieces but it is not until the puzzle is completed that the overall picture can be identified for what it is. When building a jig-saw puzzle, the most common method of doing it is by placing the picture of the box-top nearby so you can see where you're heading. This is a perfect analogy when discussing the TNW because it is a small picture being built in its own right and yet also is itself just one piece in a much bigger picture being completed on a GLOBAL SCALE. Identifying "**The Big Picture**", as American *President George Bush* senior put it, was made perfectly clear when he first publicly announced the opportunity the world now had of introducing what he called the "**NEW WORLD ORDER**" (NWO). It is considered very co-incidental that He made this declaration on 11th September 1991, exactly ten years to the day before the World changing events of 9-11, which allowed his son, *President George W. Bush*, to launch a long drawn-out war against "**The Terrorists**". More about this "down the track".



#### So you might ask -

*"Are you seriously suggesting that the events of 9-11 could be in some way associated with TNW?"*

Obviously NOT in a direct manner, but investigation will show that both are parts of a picture which is much easier to see and understand if you can see the BIG PICTURE they are a part of. Bear in mind that one part in a puzzle might be black and another white - opposites, but perfectly complementary when the picture is completed - one a part of a cloud and the other part of a road. The question that needs to be asked here is this -

#### **"Just exactly what is the NWO" ?**

1... The NWO is **NEW**, that is to say it replaces World Order or, if you like, the Old World Order with its **TRADITIONAL VALUES** which were rooted in Judeo-Christianity as laid down in the book of Genesis for which the operating principle is **LOVE**. were undergoing **RESTRUCTURING**.

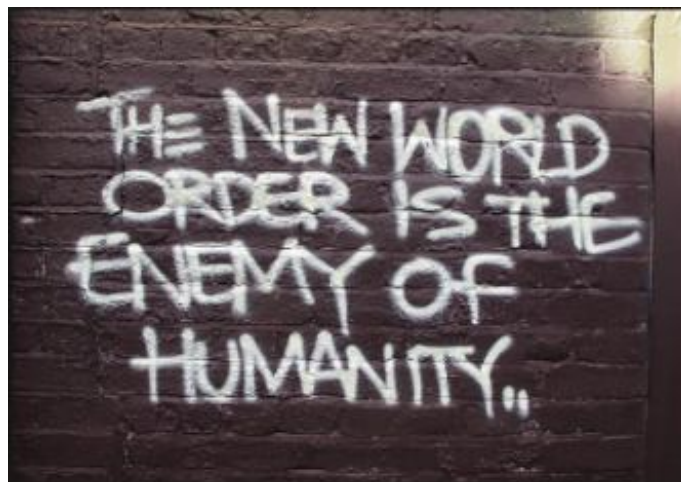

## ASPECTS OF THE NEW WORK PLACE

### THE FOUR PILLARS

#### 1... Occupational Health & Safety

OCCUPATIONAL HEALTH & SAFETY really makes it sound like the system cares for us, like we have some sort of value. **In** reality it is a system with a rigid code of rules and obligations with which workers are drilled, commonly on a daily basis, usually just prior to starting work. Nobody would be against a little education and reminders in the workplace but we then find that having been “trained” it is usual to sign a form acknowledging our training and agreeing to abide by the rules and obey. That all sounds very simple but no human being is capable of obeying rules to perfection and in fact a nybody who does sign is quite simply lying! The converse of this idea is that if an accident happens then it is obvious that the rules have not been kept to the extent required. Safety is fast becoming the criteria by which a person will be judged when applying for a job. More people are becoming aware of this and so workers are under pressure to keep their accident and incident rate as low as possible. So concerned about keeping the rate low that accidents and injuries are not reported and logged, as they are supposed to be, in case any complications develop as a result. Many workers are striving to keep their records clean, to avoid getting black marks

against their name, or the time may come when it may cause difficulties in obtaining further employment. Of course discrimination has been eliminated, hasn't it? No it hasn't been eliminated, discrimination has taken on a whole different range of forms which are “**politically correct**” across the whole spectrum of society at large and you will find whenever you encounter them they will not be in your best interests. And so it is that large workplaces may even have full time safety nurses and an ambulance, but workers avoid reporting injuries because of the repercussions - a classic example of the hypocrisy and oppression the ordinary worker faces every day as he or she tries to keep the family fed and a complete opposite result of the supposed intention it was supposed to produce in the first place. And this will be the case with virtually every aspect of the **TNW** - it produces exactly the opposite of what it is supposed to achieve. It would be suggested that the outcome is **EXACTLY** what the originators of this monstrous system intended to achieve. If you don't believe this, neither do you understand the NWO!

To be unfortunate enough to have a lost time injury is to leave a worker feeling as though he or she is the next best thing to a criminal. Safety as a concept is there to serve workers but has now been turned into a great god that all must worship. All accidents are unfortunate but it has **NEVER** been any different. Just who do these people think they are, that they are going to

turn the whole world right side up in the face of all history. Who are they that they are making laws that no human being can obey.

**Have these enforcers  
ever tripped over?**

**Have they ever cut themselves?**

**Have they ever burnt themselves  
or had a wet glass slip  
out of their hands?**

**How is it that these people are  
demanding a standard that they  
couldn't meet themselves.?**

**How is it that these things  
are dreamed up by Gurus  
sitting in their air-conditioned  
offices in the their  
lofty towers of the cities?**

The biggest problem they face is catching their finger in the filing cabinet but lay down the law for everybody else who are quite often working in very difficult circumstances. As **Jesus Christ** said to the Pharisees, the religious elite,

*"For they bind heavy burdens  
and grievous to be borne, and lay  
them on men's shoulders; but  
they themselves will not move  
them with one of their fingers."*

Matthew 23:4

I have worked for companies who have had the audacity to say

**"We are going to ELIMINATE  
accidents".**

NO they are not. What they are going to do is put their workers under ever increasing pressure which will radically affect their **HEALTH, HEALTH, HEALTH** & safety. Not much point in

safety if you end up with ulcers etc.!! The one sector of society which has done the greatest effort to eliminate accidents is aviation. They have been at it for over a hundred years and are no closer to eliminating accidents though they have greatly reduced them through better technology, training procedures, designing etc.

To keep this in perspective I'm sure all of us have seen criminals and delinquents who have done monstrous things yet keep getting what amounts to "*a slap on the wrist*" while somebody involved in an accident in his employment has been jailed e.g. the poor old truckie trying to survive in a cost cutting environment. One incident 'comes to mind of a worker who had a pipe fall on him and he was critically injured. Two or three car loads of Police attended the scene, roped the area off as a crime scene, and thoroughly interrogated twenty people to try to prove the case! (This nonsense is straight out of Soviet Russia where it was always the case that somebody **MUST** be at fault, it couldn't be the system because the **SYSTEM IS PERFECT**). They didn't but what was once considered a legitimate accident is now classed as a crime, meanwhile there is no end of people who phone the police to report people trying to break into their houses but the response from police is, "*There's nothing we can do*". The whole system is now inverted and the target for policing is now the average citizen, they can't catch the criminals, won't touch aboriginals, while the real criminals

run rampant. I'm sure everybody reading this is quite familiar! The NWO, by the way, is really the New World DISORDER - every thing is being inverted, as the Bible says

*"Woe unto them who call evil good, and good evil"* Isaiah 5:20.

It was just recently announced by **Billiton Corporation** that they are planning to introduce work shifts up to sixteen hours per day for fourteen days straight for day shift workers and sixteen hour days for seven days straight for night shift workers in the Queensland mines, under a fatigue management plan. This makes a total mockery of what OHS has been ramming down our throats for the last sixteen years! Up till now a worker has not been permitted to start another shift without at least a ten hour break. It would seem that the so-called fatigue management plan is somehow able to overcome the natural tendency to get tired over a long shift. Do you know how to spell SLAVERY. Road safety organisations and nearby communities are in uproar over the idea as workers hitting the roads after these draconian shifts will be trying to drive the long distances back to towns with the risk to all road users of them falling asleep. Put simply the aim of the NWO corporations is simple - the maximum amount of work out of the minimum number of people - and when they finally collapse, they will be thrown on the scrap heap like a piece of worn out steel and replaced by fresh fodder! After all there's plenty more in China, Korea, the Sudan or any other country where

poverty rules. More about this aspect under **"Human Resources Management"**.

It isn't hard to figure out what's coming. If the mining unions opposing this move dare to respond with strike action, there would be the possibility of the workers being sacked and replaced holus bolus by foreign workers operating under the 457 visa system which our treasonous Politicians and Governments have introduced. More about this under **"The 457 Visa Scheme"**. The corporations operating in our country virtually own our resources and now don't want to employ Australian labour when they can import cheap foreign workers. This is the end result of the Fabian Society policy introduced by Paul Keating called - **"The level playing field"**. The average Australian worker would regard it as a cynical joke.

**\*NOTE:** [457 Visas]

Complaints are surfacing of **Large Employers** of overseas workers, appearing to be able to circumnavigate the troublesome Australian **TNW** laws, by appearing to keep 457 visa people in virtual insular environments during their period of employment, allowing : sub standard accommodation, less pay, less qualification requirements for jobs applied for. Thus possibly the quality of work will not be up to our standards - breaching **OHS - WHS** - laws and so the buildings, vessels etc., being constructed may not be not structurally sound)

Now we get to the really sad part about what Occupational Health & Safety (OHS) is REALLY all about. The safety aspect is a con, a **FALSE FRONT** disguising the real intent. The whole purpose of this charade is to have a person in every workplace who liaises with Government and that person will be the workplace health and safety officer. The workplace health and safety officer is in reality being trained up to be a POLITICAL COMMISSAR, a person who observes and keeps track of all staff and employees to make sure they are not diverting from POLITICAL CORRECTNESS. The usual diatribe continually being rammed down our throats in work-place inductions - anti-discrimination, anti sexual harassment, anti vilification and equal opportunity policies etc. which are all trendy lefty **NWO** doctrines and they are all anti-Biblical. The Workplace health and safety officer is going to do in the workplace what Neighbourhood Watch is going to do in the street where you live. I am amazed at the number of movies made depicting the cold war between America and Russia, including the James Bond movies etc. and yet I have only seen one reference to a Political Commissar and that was in *"The Hunt For Red October"*. The Communists in Russia, Europe and China etc. as well as Hitler always had Political Commissars on every ship and in every workplace. Several years ago the local council included the layout of Neighbourhood Watch in with the Rates Notice. The

only possible conclusion was that this is a highly ordered system for **watching PEOPLE not houses.**

Additionally the Divisions of **OHS** are in reality separate Police forces. They have the power to investigate, fine, charge and hand over to the courts for prosecution. I can think of another society seventy years ago that had several separate competing Police forces and we fought against it!

### **Why are we now adopting virtually every aspect of it?**

The concept of safety has many enemies. Workers are finding themselves caught between supervisors who are pushing to get the job done as fast as possible while Safety Officers are slowing everybody down with their constant mantras of *"you must follow the rules"* which, as previously stated, the workers have agreed to by signing a declaration. The worker is of course caught in a devilish dialectical trap! I doubt much more need be said as workers working under this system would by now be sick of nodding in agreement.
